Subject : **Recruitment of Constable(GD)-2025 in CAPFs, SSF, NCB and Assam Rifles : Regarding conduct of PST/PET.**

Please refer to this Directorate letter of even number dated 26/06/2025 and your replies thereof on the subject.

2. Since, the MHA vide letter No.45023/19/2024-PP-Part(1)/384 dated 10/06/2025 has conveyed the approval of competent authority to conduct PST/PET and DV/DME/RME of CT/GD Exam-2025 separately, as per provisions contained in Scheme and Notification of Examination and thereafter SSC has declared the result of CT/GD Exam-2025 on 17/06/2025 and total 3,94,121 candidates (Male-353908 & Female-40213) have been shortlisted for PST/PET. Therefore, PST/PET with RFID will be conducted tentatively **from 20/08/2025 to 11/09/2025 by the Boards of CAPFs at 30 centres @ 1500 candidates per day per centre.** List of 30 PST/PET Centres as per **Appendix-"A"** is enclosed.

3. To curb the impersonation cases at PST/PET stages, sufficient numbers of biometric devices will be essentially required at each Recruitment Centres to verify identity of candidates. However, this time as PST/PET will be conducted through RFID, hence biometric verification will be conducted by the RFID Firm by their own biometric device. Further, biometric data of shortlisted candidates will be provided by this Directorate to your Forces/RFID firms shortly.

4. It is therefore requested to issue suitable directions to all Recruitment Centres for making necessary arrangements well in advance. Also ensure detailment of Board of Officers for PST/PET Centres of your Force as per DoP&T OM No.42011/2/2014-Estt.(Res) dated 13/02/2014 (copy enclosed) well in advance, so that the PST/PET can be conducted smoothly and successfully at all Centres. Composition of the PST/PET Board is as under :

The Board will consist of an Officer of the rank of Commandant/ Second-In-Command as PO and two officers not below the rank of Asstt. Comdt as M-I and M-II.

PO	:	Commandant/Second-In-Command.
Member-I	:	Dy. Commandant.
Member-II	:	Asstt. Commandant.
Co-Opt Member	:	Not below the rank of Sub Inspector.

5. Appellate authority may also be detailed for each Centre.

6. Consolidated details of BOOs of PST/PET may be provided to this Directorate as per Proforma-'A' & 'B' (in excel sheet) **by 04/08/2025 positively.**
